Monetary Developments^(*)

Money supply M0 increased from AED 50.3 billion at the end of April 2011 to AED 50.5 billion at the end of May of the same year (0.4%), while M1 decreased from AED 261.2 billion to AED 260.6 billion (-0.2%), M2 from AED 850.5 billion to AED 841.1 billion (-1.1%) and M3 from AED 1,076.1 billion to AED 1,070.0 billion (-0.6%). During the first 5 months of 2011, M0 increased by 5.6%, M1 by 11.9%, M2 by 7.0% and M3 by 8.6%.

The Money Multiplier

The money multiplier indicates by how much the money supply (M2) will grow following an increase of 1 billion Dirhams in the monetary base (currency in circulation + commercial banks' reserves at the Central Bank + certificates of deposit).

This multiplier decreased from 4.1 at the end of December 2010 to 3.6 at the end of May 2011, which was due mainly to an increase in the Central Bank's Certificates of Deposits purchased banks by AED 25.2 billion, Reserve Requirements by AED 5.2 billion and Commercial Banks' current Account at the Central Bank by AED 4.3 billion.
