Monetary Developments^(*)

Money supply M0 increased from AED 49.6 billion at the end of March 2011 to AED 50.3 billion at the end of April of the same year (1.4%), while M1 increased from AED 251.6 billion to AED 261.2 billion (3.8%), M2 from AED 834.7 billion to AED 850.5 billion (1.9%) and M3 from AED 1,048.9 billion to AED 1,076.1 billion (2.6%). During the first 4 months of 2011, M0 increased by 5.2%, M1 by 12.2%, M2 by 8.2% and M3 by 9.2%.

The Money Multiplier

The money multiplier indicates by how much the money supply (M2) will grow following an increase of 1 billion Dirhams in the monetary base (currency in circulation + commercial banks' reserves at the Central Bank + certificates of deposit).

This multiplier decreased from 4.1 at the end of December 2010 to 3.7 at the end of April 2011, which was due mainly to an increase by AED 24.0 billion in the Central Bank's Certificates of Deposits purchased by banks.
