## **Monetary Developments <sup>(\*)</sup>**

Money supply M0 increased from AED 50.5 billion at the end of May 2011 to AED 51.5 billion at the end of June of the same year (2.0%), while M1 increased from AED 260.6 billion to AED 262.2 billion (0.6%), and M2 from AED 841.1 billion to AED 851.9 billion (1.3%). However, M3 decreased from AED 1,070.0 billion to AED 1,062.7 billion (-0.7%). During the first 6 months of 2011, M0 increased by 7.7%, M1 by 12.6%, M2 by 8.3% and M3 by 7.9%.

### **The Money Multiplier**

The money multiplier indicates by how much the money supply (M2) will grow following an increase of 1 billion Dirhams in the monetary base (currency in circulation + commercial banks' reserves at the Central Bank + certificates of deposit).

This multiplier decreased from 4.1 at the end of December 2010 to 3.6 at the end of June 2011, which was due mainly to an increase in the Central Bank's Certificates of Deposits purchased banks by AED 24.0 billion, Reserve Requirements by AED 7.4 billion and Commercial Banks' Current accounts at the Central Bank by AED 9.5 billion.
